OPEN AND ADJUST THE 2022 – 2023 FISCAL YEAR BUDGET – RESOLUTION R23-12

Ty Bailey, City Manager, explained the current year budget had been amended to reflect actual amounts received from the County and the School District. He stated the payments to the hotel, County and School District had been made and the RDA purchased water rights this year.

He stated the tentative budget for the 2023 – 2024 fiscal year followed the same pattern but would allow for one more project within the boundary of the RDA. He suggested the RDA continue putting money aside and possibly entertain a proposal to start doing infrastructure. He also mentioned the increase in line-item Professional and Technical for assistance from Zions Bank on the annual report for the RDA

Gary Crane, City Attorney, arrived at 5:53 p.m.

Ty said all the buildings on Commercial Street had been renovated or were in the process of being renovated. The remodel of the Vallis Hotel was the only project the RDA was still obligated to do once it was finished. He suggested a budget for infrastructure would help with streets and possibly do a study to start working on realigning properties on the backside of Commercial Street to help with traffic flow.

Board Member Alexander asked how much of the \$165,000 in line-item Business Loan/Grants was committed.

Ty stated \$128,700 was committed for the hotel payment.

Board Member Richins reported the entities on the COG had expressed their support of the RDA and its performance the last several years.
