

RESOLUTION #11-04
MORGAN CITY
PARK RESERVATION FEES AND REGULATIONS

Be it hereby resolved that the Morgan City Council does adopt the following fees for park reservations and regulations pertaining to scheduling reservations:

FEES

Large Bowery \$40.00 (for first four hours, \$10.00 per hour for each additional hour)

No fees will be charged to Civic and Church organizations within the community.

Refunds due to inclement weather will be given only if city office is notified within three (3) days of reservation date. Any other refunds will only be given if office is notified of cancellation one week prior to reservation date.

RESERVATION REGULATIONS

The calendar for reservations for Riverside Park will be opened for scheduling on the 1st working day of February of each new year

- (1) No dates will be scheduled before the calendar opening.
- (2) Reservations will be taken on a first come, first serve basis.
- (3) Reservation fees must be paid at time reservation is made.
- (4) Non-paying organizations will be required to verify their reservations one-week prior to the date scheduled.
- (5) Any swapping of dates will be handled by the parties involved. Notification to the city office of the change must be made one week prior to the date scheduled.
- (6) Any special needs for any group should be brought to the attention of the city and the park caretaker beforehand.
- (7) All parties using the park will pick up a copy of the rules and regulations concerning the park at the city office.
- (8) Areas of the park not reserved may be used by other parties for other purposes or be watered during time of scheduled reservation.

PARKS AND PUBLIC GROUNDS

AN ORDINANCE ADOPTING A PARKS AND GROUNDS SUPERVISOR AND
SETTING PARK AND RIVER WALKWAY REGULATIONS, REPEALING
CONFLICTING ORDINANCES AND RESOLUTIONS; AND, PROVIDING FOR
SEVERABILITY AND AN EFFECTIVE DATE.

Parks and Grounds Supervisor

- A. Morgan City shall hire an individual to conduct the operation and maintenance of the city parks. Such hiring shall be done by the City Council.
- B. The salary of the Parks and Grounds Supervisor shall be fixed by the City Council.
- C. It shall be the duty of the Parks and Grounds Supervisor to supervise the operation and maintenance of the City's parks and public grounds in accordance with the provisions of the City ordinances and the rules and regulations adopted by the City Council. It shall be the duty of the supervisor to keep suitable records of the parks and public grounds, make periodical inspection of the same, and upon request, report to the City Council the condition thereof.

Park/River Walkway Regulations


- A. For the protection of the health and safety of the citizens of the City, the following park and walkway regulations are adopted:
 - 1. **Camping.** There shall be no overnight camping in the park.
 - 2. **Vehicles on Lawn and Walkway.** There shall be no motor vehicles permitted on the lawn or the walkway, excluding those used by persons with disabilities. All vehicles must park in designated parking areas.
 - 3. **Horses on Lawn.** There will be no horses allowed on the lawn or on walkway.
 - 4. **Alcoholic Beverages.** There will be no alcoholic beverages neither used or consumed in the park, nor brought into the area covered by the park by any person.
 - 5. **Littering.** Littering is prohibited within the city park or on the walkway.
 - 6. **Park Hours.** The park is closed between 11:00 p.m. and 6:00 a.m. No vehicles may be left in the park during these hours.

7. **Conduct.** Persons using the park shall not engage in any kind of dangerous, hazardous, illegal, or rowdy conduct within the confines of the park or walkway.
8. **Exceptions.** Any exceptions to the above rules and regulations must have prior approval by the park supervisor and/or the city council.
- B. **Violation.** Every person convicted of violating the park/walkway regulations as prescribed herein shall be guilty of a Class C misdemeanor and subject to penalty as provided in Utah Code.
- C. **Repeal.** All ordinances or resolutions or parts of ordinances or resolutions in conflict with this ordinance are hereby repealed.
- D. **Severability.** If any provision of this ordinance shall be held invalid, its invalidity shall not affect any other provision of this ordinance that can be given effect without the invalid provision, and for this purpose the provisions of this ordinance are hereby declared to be severable.
- E. **Effective Date.** This ordinance will become effective upon passage.
