Owner warrants that Owner has acquired and will maintain Liability Insurance sufficient to support the promises, releases and waivers contained in this agreement.

Owner acknowledges that Owner has been advised to consult legal counsel and have had the opportunity to consult with legal counsel prior to entering into this release of liability.

Owner understands and agrees that, by signing this Hold Harmless agreement, that Owner relinquishes all rights or claims to adjudication or recourse to which Owner may be entitled in relation to any liability arising under this contract. Owner also expressly acknowledges and agrees that this 'Hold Harmless' agreement applies to Third Party claims arising from any of the above activities.

Owner warrants that Owner enters into this agreement with full knowledge of the meaning and future effect of the promises, releases and waivers contained herein.

Owner warrants that Owner has entered into the releases and waivers contained in this Agreement voluntarily and makes them without any duress or undue influence of any nature by any person or entity.
